Dear Mr. Chairman:

This letter responds to the request contained in Section 113 of Public Law 110-5, "Revised Continuing Appropriations Resolution, 2007," which calls for the Department to provide a report to the Committees on Appropriations of the House of Representatives and the Senate containing a spending plan for the Defense Health Program. A report detailing the planned expenditures for the Department's military construction, family housing, and Base Realignment and Closure (BRAC) accounts will be provided separately.

The table below provides the Department's Fiscal Year 2007 Defense Health Program (DHP) allocation at the Budget Activity Group level for the Operation and Maintenance (O&M) account, and at program element level for the Procurement and Research, Development, Test and Evaluation (RDT&E) accounts. For O&M, the allocation reflects the FY 2007 President's Budget request, with the additional \$244.8 million provided by Congress allocated to the Private Sector Care Budget Activity Group to partially offset unrealized savings associated with initiatives for benefit reform and pharmacy acquisition that were not authorized. We greatly appreciate your assistance in mitigating this potential budget shortfall.

Additionally, the Procurement appropriation was \$21.4 million less than the President's Budget request and the allocation has been reduced accordingly. The RDT&E appropriation was \$217.4 million above the President's Budget request, and required that \$217.5 million be directed to peer-reviewed cancer research programs; the RDT&E allocation reflects this requirement.
