# Defense Health Program Quarterly Budget Execution First Quarter, FY 2016

**Issue:** As requested by the Joint Explanatory Statement, accompanying the Department of Defense Appropriations Act, 2016, provides the first quarter fiscal year 2016 budget execution data for all Defense Health Program Activities.

Report Request: The language states:

The Committee further directs the Assistant Secretary of Defense (Health Affairs) to provide quarterly reports to the congressional defense committees on budget execution data for all of the Defense Health Program budget activities.

**Summary:** The first quarter budget executed while under Continuing Resolution until the Consolidated Appropriations Act, 2016, (P.L. 114-113) was enacted on 18 December, 2015. Additional information for the appropriations is attached.

Note: The Department of Defense's FY2016 President's Budget submission for the Defense Health Program Operation and Maintenance Private Sector Care Budget Activity Group, \$14,892.683 million, was a realistic cost projection for the delivery of health care services and provision of pharmaceuticals to beneficiaries. The \$505.281 million congressional reduction to the Private Sector Care Budget Activity Group resulted in an enacted budget of \$14,387.402 million, which may not be sufficient to fund the annual requirement. The cost of providing health care services in the private sector is closely monitored to ensure that a timely prior approval reprogramming request will be submitted to Congress if additional funding is required.
