- 9+ years, ended in 2017
- ~\$1 billion in contracts

OMNIBUS IV

- Awarded in June 2022
- Enhance medical research and development programs
- Translation science support and services
- Primarily RDT&E, other funds based on Task Order (TO) and scope determination
- Base Awards made by Market Segment—may include more than 1 Market Segment and Proficiency Area



Scope: OMNIBUS IV Contract: IDIQ \$10B over 10 years

Omnibus IV: Buys/Doesn't Buy Examples

- Buys
 - TOs from a variety of funding sources
 - Translational science support and services (new)
 - World-wide (mostly!) TOs
 - Access to 56 Primes with unrestricted opportunities for subcontracting (IAW FAR)
- Doesn't Buy
 - Requirements not related to Medical R&D (as per SOO)
 - Grants
 - IPAs
 - OTAs
 - Personal Services, unless PCO approved



How to Obtain Award?

- Requirements Owner
 - Identifies requirement
 - Confirms funds available
 - Prepares PWS/SOO/SOW (as applicable) with Task Order Contracting Officer (TOCO or TOKO)
 - Requests scope determination from TOCO
- TOCO or TOKO
 - Submits scope determination request (dropbox)
 - Works with OIV PCO authorization to use contract
 - Works with requirement owner to accomplish solicitation
 - Appoints Task Order (TO) COR and provides TO documentation to PCO
 - Releases RFP in Symphony
- Task Order COR: Executes COR duties as specified by the TOCO
