





Topic Summary

- The Profile & Health Plan (P&HP) webinar is a broad overview to provide assist the Uniform Business Office (UBO) responsibilities.
- The webinar will provide an overview of the Profile & Health Plan topic, not just examples. Goal is to assist new and experienced UBO staff with a broader knowledge, how to identify and provide to leadership details where the billable encounters are with potential P&HP errors. Not all sections are the UBO staff responsibility, information was provided to show the importance of selecting the accurate P&HP for the encounter.
- A deeper look at the building blocks of a P&HP are included.
- There are so many scenarios, focus is on understanding the why and outcome may assist with selecting the P&HP associated with the encounter.

Profile & Health Plan Webinar - GOAL

- ACCURACY!
 - One word “Accuracy” for every Encounter, billable and non-billable.
- Accurate P&HP required for every encounter.
 - Registration Perspective- Patient’s master table for active P&HP.
 - Encounters Perspective- Patient’s P&HP for the encounter.
 - P&HP data populated during the MPI/DEERS retrieve.
 - P&HP data manually added.
- Clean Claims require accurate data elements such as medical service, encounter type, injury information, diagnosis code (billable or non-billable) and ...


Profile & Health Plan – Why does it matter?

- Accuracy!
- Inaccurate selection of a P&HP delays the resolution of the encounter, to include charges adjusted off for Tricare, Civil Service Occupational Health, charges billed to Coast Guard, NOAA, Blue Cross, or the patient (not all inclusive).
- Inaccurate selection of a P&HP may generate a Patient Statement for a Tricare beneficiary who is entitled to care.
 - UBO staff manually reviews many of the patient responsibility encounters to validate there is not a Tricare benefit.



Steps: Add OHI (1)

Add Other Health Insurance (Add-OHI)

Add insurance health plans from Experian or from patient's insurance card, or DD Form 2569. The sections are for straightforward processes. Additional steps will be added for situations not addressed.

New insurance was identified during check-in and needs to be added.

New OHI – Registration Perspective



Registration Perspective

Start process in Registration Perspective to add new OHI.

1. Select Modify- to add OHI to Insurance Tab.



2. Patient tab, add Facility DMIS-ID if blank. Select Search-, then type in DMIS ID in next screen.






3. Select Add+ to add new medical insurance. Click OK to pop-up.

5. Click -Contains and type in partial name, then click > and select address. Click Select Health Plan when finished to select.







- OHI is Sequence 1 for US Military Service Tricare.
- OHI is not added to Other Uniform Services Tricare.
- OHI is Sequence 2 for MSA-Public.

Encounter Steps: Update Profile & Health Plan (1)


Encounter Perspective

The Registration Perspective is at the patient level, or the patient master list of current Profiles & Health Plans. The Encounter Perspective is at the encounter level, this is where the encounter specific P&HP are associated.

On Monday an encounter may be for Occupational Health, the OccHlth P&HP would be selected. On Wednesday an encounter may be for Family Practice, the Tricare P&HP would be selected. Updates to the Registration Perspective should not affect the Encounter Perspective unless manually updated.

Update Profile & Health Plan (Update-P&HP)

1. Select the encounter to update, use Search- for patient, or Encounters Tab, double-click the encounter, or encounter was selected from a work queue.
2. Insurance Tab, review the Profiles and Health Plans, the below example is incorrect.
 - OHI health plans are inaccurate.

Adding OHI – Miscellaneous

- Adding Other Health Insurance - Medical
 - Only add OHI to the DMIS IDs that are part of your Billing Entity.
 - Blue Cross / Blue Shield Plans-
 - ✓ The BC/BS health plan will be associated with the billing entity where the patient resides. An admitted non-Tricare patient would be associated with the same MTF; next emergency care.
 - ✓ The other billing entity may add the OHI at the encounter level. An OHI plan may be added as unassociated in the Registration Perspective for future reference.
 - ✓ Billing for a Blue Cross not in your state causea SSI errors (CH HELD).

- There are additional P&HP errors in the DNFB Status and Billed Status.

- 1) Self Pay Primary FC are missing the P&HP
- 2) Tricare as Primary FC would not have a Secondary FC. (excluding prior final benefit).
- 3) Medicare would never be Primary FC, always secondary to non-Tricare FC.
- 4) Civilian Emergency as Primary FC with Civilian Emergency as Secondary FC is incorrect. Research rest.

MPI Retrieve – Updates DEERS Data

- MPI retrieve is the first step to sync patient data in GENESIS with GIQD/DEERS. When this is done incorrectly errors may occur, to include “Self-Pay ‘WI’” and “Incorrect Coordination of Benefits ‘WI’”. DEERS checks are required by regulation.



- Review the data for any unmatched sections.
- Select ‘Retain all Cerner values’ under Cerner.
- To select a DEERS item, just click on the radio button. Select Update when finished.

P&HP/Financial Class – First Piece of the Puzzle

- The financial class is a key data element for the Profile & Health Plan logic.
- The financial class is combined with the health plan.
- The billing rates are associated with the financial class, to include if an adjustment is system generated, is a claim form generated or a patient statement. There are some rules-built with the combination of financial class and health plan.
- Work items, billing, and adjustment rules are usually built using the FC.
- Other Health Insurance (OHI) has several financial classes, they cannot stand alone without another financial class. All are manually added.


- MPI/DEERS
 - “DEERS – YES” The P&HP are updated during the MPI/DEERS retrieve.
 - “Manual – 1” The P&HP require manual set-up, the ‘1’ = ‘retain on the next MPI retrieve’.
- OHI – SEQ
 - “Yes – Seq1” OHI maybe added as Seq1 and Tricare as Seq2.
 - “No OHI” Do not add OHI.
 - “Yes – Seq2” OHI maybe added as Seq2 and other health plan as Seq1.
 - “OHI” OHI is Seq1 or Seq2, never solo.
 - OHI/Seq ‘Yes’ are situational, the profile and health plan are required to complete.
 - Seq1 / Seq2 is the sequence for OHI.

- OHI is always Primary (Sequence 1) to Tricare non-AD.
- Only the OHI marked with Sequence 1 may be added to a Tricare non-AD profile.

- Prior to eligibility benefits in DEERS/GIQD a manual P&HP may need to be created for service members and potential service members. This is temporary, an end date will be required after the initial exams are completed and Tricare eligibility is populated from GIQD/DEERS
- Add P&HP to Registration Perspective.
- Health Plan is Tricare Entry Evaluation Exam (Service).
- Service is US Military – Air Force / Army / Marines / Navy /
- Health Plan is Tricare Entry Evaluation Exam (Other Service)
- Service is Other Uniformed – NOAA / USCG / USPHS
- Profile is DOD-RECRUIT/APPLICANT.
- No- OHI.

- Tricare Prime would be selected in these examples.



Patient was eligible on date of service. Verify the eligibility in GIQD/DEERS. One reason is a deceased patient, and the P&HP were not selected at check-in.
- Add P&HP to ENCOUNTERS Perspective.
- Health Plan is DOD- Benefits Expired.
- Profile is DOD-EXPIRED/UNASSOCIATED.
- Verify eligibility in GIQD/DEERS.
- Situational - OHI.



DOD-VA SHARING

- DOD-VA Sharing benefit is only selected when there is an **authorization** for services, otherwise select Tricare.
 - No- OHI.
 - VA Pays.
 - Retain-on-Retrieve Manual



